We would like to put together a comprehensive list of items to raise with the City – feedback before the meeting is welcome.

\* **State issues** – one issue we've also heard about is street racing/noise on I-495, but the State Police at our last virtual meeting indicated that their enforcement powers are limited by state law. This would be an issue to raise with our representatives in Richmond – but this also would be the time to identify other matters (not necessarily traffic related) for the next legislative session for State Senator Adam Ebbin and newly elected State Delegate Elizabeth Bennett-Parker.
